4. ORGANIZER AGREEMENT

For the purpose of inducing WSWC to grant OFFICIAL SANCTION for the herein above-mentioned towed water sport tournament, the undersigned hereby REPRESENTS, CERTIFIES and AGREES that:

- (1) The TOURNAMENT SITE, EQUIPMENT and all FACILITIES required therefore, as well as the personnel for the operation of the tournament, shall be suitable and adequate to meet the applicable standards and specifications of WSWC. It shall be the sole responsibility of the sponsor to provide the same.
- (2) JUDGING and OFFICIATING shall be conducted exclusively by qualified WSWC judges and officials, or equivalent. If this application is granted, the names of each of the officials shall be forwarded to WSWC on the Officials Record Form. These judges shall be directly responsible for the application of the official rules of WSWC at the tournament. There shall be no substitution for the major officials originally designated, without similar approval, but other qualified and accredited judges may assist at the tournament.
- (3) All matters relating to the ADMINISTRATION and CONDUCT of the tournament, from preparation to conclusion, including the issuance of notices, preparation of schedules, processing of entries, conduct of events, and certification of results, shall be handled in strict conformity with the official tournament rules and requirements prescribed by WSWC in its official Rule Book and other pertinent data (as construed and applied by the judges and other authorized officials of WSWC) applicable at the time said tournament is held.
- (4) **ORGANIZER'S RESPONSIBILITY** - The undersigned, holding the official position indicated below, agrees to:
 - Provide a minimum of \$2,000,000 of liability insurance for each sanction day;
 - Require each participant to be a current member in good standing of a provincial water ski/wakeboard association, showing proof of such prior to any participation in the event;
 - Within 7 days of the completion of the tournament, forward a complete electronic set of tournament results to mwallace@waterski-wakeboard.ca. Tournaments that do not comply may not be sanctioned in the future.**
 - Mail a hard copy of the officials record and injury report form to the WSWC National Office.

I hereby agree to all sanction requirements as per WSWC Rule Book Appendix VIII and I hereby attest to the information provided.
